

BEFORE THE BOARD OF COLUMBIA COUNTY COMMISSIONERS

RESOLUTION #2022-08

IN THE MATTER OF MAXIMUM LAWFUL SPEED LIMITS ON VARIOUS COUNTY ROADS.

WHEREAS, RCW 46.61.400 specifies a maximum lawful speed of fifty (50) miles per hour on County Roads, and;

WHEREAS, RCW 46.61.415 authorizes the Board of County Commissioners to establish the maximum lawful speed limit should an engineering and traffic investigation find that the maximum speed permitted under RCW 46.61.400 is greater or less than is reasonable and safe under the conditions found to exist upon a highway or part of a highway; and,

WHEREAS, The City of Waitsburg has requested that Columbia County authorize a wheeled all-terrain vehicle "sunset cruise" and "Karen Huwe Mahoney Memorial ATV Poker Ride" on various county roads; and,

WHEREAS, RCW 46.09.455 authorizes the use of wheeled all-terrain vehicles only on county roads with a posted speed limit of thirty-five (35) miles per hour or less; and,

WHEREAS, The County Engineer had performed an investigation and recommends that the speed limit be reduced to thirty-five (35) miles per hour during the time that the Waitsburg Poker Run will be utilizing various county roads.

NOW, THEREFORE BE IT HEREBY RESOLVED, that the maximum lawful speed limit is thirty-five (35) mph on the following roads for the period of 4:00pm to 8:30pm on Friday May 20, 2022:

Wilson Hollow Road (Road No. 10170) from MP 2.19 to MP 3.13

Nordheim Road (Road No. 10300) from MP 0.00 to MP 2.59

Whiskey Creek Road (Road No. 10530) from MP 2.93 to MP 3.40

Warren Road (Road No. 10920) from MP 0.00 to MP 1.66

Bundy Hollow Road (Road No. 11160) from MP 3.64 to MP 4.96 & from MP 7.05 to MP 8.50

Payne Hollow Road (Road No. 12350) from MP 9.36 to MP 8.03

Canright Road (Road No. 11430) from MP 4.94 to MP 0.84

Dustin Hollow Road (Road No. 11170) from MP 2.64 to MP 0.00

Bundy Hollow Road (Road No. 11160) from MP 0.75 to MP 3.65

BE IT FURTHER RESOLVED, that the maximum lawful speed limit is thirty-five (35) mph on the following roads for the period of 12:30pm to 4:30pm on Saturday May 21, 2022:


- Wilson Hollow Road (Road No. 10170) from MP 2.19 to MP 3.13
- Nordheim Road (Road No. 10300) from MP 0.00 to MP 2.60
- Whiskey Creek Road (Road No. 10530) from MP 2.93 to MP 10.22
- Payne Hollow Road (Road No. 12350) from MP 11.06 to MP 15.82
- McCown Road (Road No. 10050) from MP 0.00 to MP 0.38
- Wilson Hollow Road (Road No. 10170) from MP 3.95 to MP 3.13


