

## **INTERLOCAL COOPERATION AGREEMENT BETWEEN FERRY COUNTY AND COLUMBIA COUNTY**

THIS INTERLOCAL COOPERATION AGREEMENT ("Agreement") is made and entered into by and between, Columbia County and Ferry County, both political subdivisions of the State of Washington and jointly referred to as "the Parties".

### **I. RECITALS**

Ferry County is a political subdivision of the State of Washington; and constitutes a public agency as defined in RCW 39.34.020(1).

Columbia County is a political subdivision of the State of Washington; and constitutes a public agency as defined in RCW 39.34.020(1).

Counties may sell, transfer, exchange, lease or otherwise dispose of any real or personal property to another government entity without regard to bid laws; and, RCW 39.33.010 authorizes such transactions "on such terms and conditions as may be mutually agreed upon by the proper authorities." However, because of the requirement of RCW 43.09.210, intergovernmental transactions authorized by RCW 39.33.010 should be based on the "full value" of the property.

THEREFORE, it is mutually agreed that:

### **II. PURPOSE**

The purpose of this Agreement is provide for the conveyance of a certain piece of equipment from Columbia County to Ferry County at agreed upon fair market value pricing.

### **III. COMPENSATION**

Columbia County agrees to sell to Ferry County, for a sum of \$75,950.00 (tax included), the following piece of equipment: 2021 Ram 3500 (VIN) 3C63R3JL9MG617810

### **IV. TERM AND TERMINATION**

This Agreement shall remain in full force and effect only for the purposes of completing this transaction and transfer of ownership of said equipment.

### **V. SEVERABILITY**

If any provision of this Agreement is held invalid, the remainder of this Agreement shall not be affected thereby if such remainder would then continue to serve the purposes and objectives of the Agreement as determined mutually by both Ferry and Columbia County.

**VI. EFFECTIVE DATE**

This Agreement shall take effect as soon as it has been adopted by both parties as signed below.
