Permittee acknowledges and accepts those conditions, and hereby waives any and all claims that might be brought on account of obvious or latent conditions, whether natural or artificial, existing on the Closed Roads, whether known or unknown to the County, and whether marked or unmarked. Permittee acknowledges and accepts all risks of any kind whatsoever associated with access to the Closed Roads and Permittee's activities thereon, including, but not limited to personal injury or death and damage to property. These limitations shall be in addition to those limitations set forth in RCW 4.24.210.

(Please initial) _____ By accepting this Permit, Permittee agrees to reimburse, indemnify, defend and hold the County and its officials, employees, agents, representatives and volunteers, harmless from and against all claims, causes of action (including, without limitation, those relating to personal injury), liabilities, damages, costs and expenses (including, without limitation, attorney fees and costs at trial and on appeal) of any nature arising from (a) use of the Closed Roads by Permittee and his/her/their immediate family or (b) violation of the terms of this Permit (including, without limitation, failure to abide by any rules and regulations governing use of the public roads).

(Please initial) _____ This permit, once approved, is valid only for the named permit holder operating the specific vehicle indicated above. If approved, the County may revoke the permit at any time, for any reason and without prior notice to the holder. This permit does not allow use of roads closed due to an emergency, including but not limited to flooding or fire.
