

**BEFORE THE BOARD OF COLUMBIA COUNTY COMMISSIONERS**

**RESOLUTION #2020 - 07**

**IN THE MATTER OF DECLARING INTENT TO VACATE A PORTION OF ECKLER STREET (COUNTY ROAD NO. 14410)**

**WHEREAS**, the Board of County Commissioners has received a petition for abandonment of a portion of County Road 14410, known as Eckler Street; and

**WHEREAS**, the Board of County Commissioners has determined that the petition meets the requirements of RCW 36.87; and

**WHEREAS**, the portion of road to be vacated is the section that dead-ends and serves only the adjacent property owner.

**NOW, THEREFORE BE IT HEREBY RESOLVED**, that the Board of Columbia County Commissioners intends to vacate a portion of Columbia County Road No. 14410 (locally known as Eckler Street) and described as follows:


Commencing at the N.E. corner of Lot 1 of Block "K" in Dexter's Addition to Dayton as shown on Book 1 of Plats at pages 60 and 61; thence N. 77°13'00" E. 30.00 ft., along the S. right-of-way of Old Mustard Hollow Road, as shown on County Roads Book "D" at pages 488 through 494, to the point of beginning for this description; thence N. 10°02'21" E. 44.45 ft. to the point of intersection of the N. right-of-way of Eckler Street, being labeled "Mountain Road" as shown on said Dexter's Addition to Dayton, and the W. right-of-way of the alley in Block "J" of Dexter's Addition to Dayton; thence N. 82°05'38" E. 16.66 ft. to the point of intersection of the N. right-of-way of Eckler Street and the E. right-of-way of the alley in Block "J" of Dexter's Addition to Dayton, said point also being the beginning of the N. right-of-way of the Old Mustard Hollow Road; thence N. 73°28'08" E. 298.66 ft., along the N. right-of-way of Old Mustard Hollow Road, as described in the field of notes in County Roads Book "D" at page 492, to the beginning of the abandonment of Old Mustard Hollow Road as described in Book "J" of the Columbia County Commissioners Records at pages 285 through 287, dated October 7, 1963; thence S. 30°34'14" E. 41.23 ft. to the S. line of the right-of-way of Old Mustard Hollow Road; thence S. 73°28'08" W. 303.13 ft. along the S. right-of-way of Old Mustard Hollow Road; thence S. 77°13'00" W. 41.98 ft. along the S. right-of-way of Old Mustard Hollow Road, to the point of beginning for this description. Containing 0.30 acres.

**AND, IT IS HEREBY FURTHER RESOLVED** that the Board of Columbia County Commissioners shall hold a public hearing on the proposed vacation. The County Engineer shall cause notice of the public hearing to be published as required by law.

**AND, IT IS HEREBY FURTHER RESOLVED** that the Board of Columbia County Commissioners directs the County Engineer to prepare the required Engineer's report on the proposed vacation.
