RESOLUTION #2019 - 51

IN THE MATTER OF 2020 COLUMBIA COUNTY ROAD LEVY


WHEREAS, the Columbia County Board of Commissioners has met and considered the County Road budget for the calendar year 2020; and

WHEREAS, the Columbia County Board of County Commissioners, after hearing and duly considering all relevant evidence and testimony presented, determined that County Road requires a regular levy which includes an increase in property tax revenue from the previous year plus amounts resulting from the addition of new construction and improvements to property and any increase in the value of state-assessed property, and amount authorized by law as a result of any annexations that have occurred and refunds made, in order to discharge the expected expenses and obligations of the district and in its best interest.


NOW, THEREFORE BE IT HEREBY RESOLVED, by the Columbia County Board of County Commissioners that an increase in the regular property tax levy for County Road is hereby authorized for the 2020 levy in the amount of \$16,901.89 which is a percentage increase of 1% from the previous year. This increase is exclusive of additional revenue resulting from the addition of new construction and improvements to property and any increase in the value of state assessed property, and any additional amounts resulting from any annexations that have occurred and refunds made.


